<u>Prime Minister</u> Ehud Barak has filmed an <u>elections advertisement aimed at</u> the Arab sector in which he <u>expresses regret</u> for the killing of 13 Arab <u>demonstrators</u> by police <u>during protests</u> in the Galilee in October last year. Barak <u>considered</u> a full-blown <u>apology</u>, but in the <u>end settled</u> for an expression of regret.

The Likud <u>intends</u> to <u>continue ignoring</u> the <u>issue</u> of the Lebanon War, during which Ariel Sharon was <u>defense minister</u>, in its advertisements. Sharon's <u>central role</u> in the Lebanon War is a <u>key feature</u> in Labor's election commercials. On Tuesday, the day <u>after</u> the first ads were aired on television, Likud <u>officials strongly attacked</u> what they called the "<u>aggressive</u> and <u>excessive</u>" use of <u>bereavement</u> in Labor's ads which <u>included footage</u> from the 1982 <u>war</u>.

The <u>High Court of Justice rejected</u> a <u>petition Tuesday to disqualify Likud candidate</u> Ariel Sharon from running for prime minister. Lawyer Shmuel Saadia, a <u>member</u> of the Labor central <u>committee</u>, <u>submitted</u> the petition on the basis of the Kahan <u>Commission report</u> into the 1982 Sabra and Shatilla <u>massacre</u> of Palestinians, which found Sharon <u>unfit</u> to <u>continue</u> as defense minister, and a 1998 <u>court ruling</u> in dismissing Sharons <u>libel suit against</u> Haaretz. A panel of three High Court <u>judges</u> ruled there was no <u>reason</u> to <u>review</u> the <u>decision</u> by Justice Mishael Cheshin confirming Sharons eligibility to run for prime minister.
